It has a long history of social inclusion, and its mission is to end social inequity through life-changing teaching, learning, research and knowledge exchange.

The Access and Participation Plan is designed to further this mission, ensuring that all students can access Marjon, succeed in their studies and progress into meaningful graduate-level work or study.

Fees we charge

Home undergraduate tuition fees for 2025 entry are £9,535 per annum for full-time students. Tuition fees for home students studying part-time will be calculated on a pro-rata basis. International student fees are higher, and postgraduate fees differ. Tuition fees may be subject to an annual increase due to inflation, subject to the fee cap.

What we are aiming to achieve

Our Access and Participation Plan aims to improve outcomes for specific groups of students. The plan is led by our data, which shows that some groups have been less likely to succeed.

- We want to increase the proportion of students from more deprived backgrounds. We also want to support these groups to reach the end of their degree at the same rates as more privileged students, to attain the same results, and to move into graduate-level work or study at the same rates.
 - We have a particular focus on supporting male students from more deprived backgrounds to complete their degree at the same rate as female students from the same backgrounds.
- We also want to support students with a declared cognitive or learning difficulty to attain the same degree standards as students with no declared disability.
- We want to support students with multiple disabilities to move into graduate-level work or study at the same rates as those with no disability.

What we are doing to address keys risks to equality of opportunity

Our plan includes:

Supporting local people to get into university, through attainment-raising support like revision schools, and summer schools, through sharing information advice and guidance, working with specific communities.

Expanding routes into university, through more flexible options and apprenticeships, partnerships with local providers, and through developing contextual offers.

Developing and implementing a new way of teaching through a new curriculum framework which is designed for students with multiple responsibilities going into flexible, ever-changing careers.

Improving use to data and systems to identify students who are engaging less, or may not be achieving what they are capable of.

Improving wellbeing and mental health support through engaging both students and staff in the challenges of improving mental health.

Offering support, advice and subsidised activities for students experiencing financial difficulties.

Improving the range of inspirational speakers our students meet to support them into graduate-level jobs.

Developing advice for both students and employers on workplace disability support available.
